Resume 10.15.48 Counsel indicates Mr. Hunt waived his appearance today.

The Court inquired as to whether the order to show cause with the parent time issue has gone through the mediation process. Counsel indicates it has not. That motion will not be heard today, pending mediation of the parent time issues.

Counsel read into the record a partial stipulation of the parties:

- 1. Mr. Goodman will provide within a week the Rule 26.1 discovery.
- 2. The parties will mediate within 30 days.
- 3. The previous temporary order regarding sole legal and physical custody to the Petitioner, as well as no change to the \$373 per month child support will remain in effect.
- Mr. Goodman indicates he has authority to enter into this agreement. The Respondent indicates he understands and agrees with the stipulation as read into the record.

The Commissioner accepts the partial stipulation of the parties as read into the record and RECOMMENDS on issues still in dispute:

1. The Respondent has requested the parent time restriction be lifted. The parties will utilize the reunification schedule under 30-3-35.5.

The first month will be pursuant to sub-paragraph A; the second month pursuant to 30-3-35(a); the third month pursuant to 30-3-35(b); the fourth month pursuant to 30-3-35(c).

- 2. The parties shall attempt to locate a person or setting familiar to the child for the visits, possibly a daycare provider.
- 3. Health insurance shall be pursuant to statute.
- 4. The parties are mutually restrained from doing anything which might diminish the love and affection of the child for the other party.
- 5. The daycare shall be pursuant to statute. Daycare may be provided by a family member, but proof needs to be provided of actual payment for daycare.

Mr. Helgesen is directed to prepare the order.

1. The Respondent will have parent time for 4 weeks, commencing 2/19/13, to take place at his parents home, with all grandparents present as they choose. This will take place each Monday 5-7 pm, Tuesday 5-7 pm, and Saturday at 9-11 am.

The Respondent will pick up the child at Brayden Academy.

- 2. Following the first 4 weeks, the parent time will change to Mondays 1-4 pm, Tuesdays 1-4 pm, and Fridays 10 am to 1 pm, for the next 4 weeks.
- 3. After the second 4-week period, parent time will be pursuant to statute.

The Commissioner accepts the partial stipulation of the parties as read into the record, after verifying the parties understand and agree to the terms. The Commissioner recommends the partial stipulation be implemented into an order.

The Commissioner, after hearing argument on the remaining issues, RECOMMENDS:

- 1. This Court finds NO willful violation of the court order; contempt is NOT certified on the violation of parent time issue.
- 2. The Court finds prima facie evidence that the Petitioner was in violation of the January 10, 2013 order regarding reunification schedule. Her contempt is CERTIFIED, but is STAYED.

The Petitioner may purge her contempt by complying with the agreed-upon parent time schedule. If an emergency disrupts the parent time during that time, make up parent time can correct the problem.

- 3. Make up parent time is RESERVED.
- 4. Fees are CERTIFIED, but STAYED to allow the Petitioner to comply with the parent time schedule agreed to.
- 5. Counsel agree on the record that the grandparents home is available for the visits.

HEARING

This matter is before the court on Petitioner's Motion for Order to Show Cause and Respondent's Counter-Motion.

Counsel informs the court the parties have reached a partial stipulation as read onto the record by attorney Stacey G Schmidt as follows:

- parties agree there needs to be a reintroduction period for parent-time;
- the Respondent needs to provide any roommates name and date of birth so a background can be done on that person; the Respondent needs to keep the Petitioner apprised of his current physical and email address;
- the Division of Child and Family Services (DCFS) must do a physical walk through of his address prior to having inhome visits;
- there will be seven visits that will be in this reintroduction period with the first three visits being supervised with Willwin, an agreed upon supervisor, some other agency or through DCFS;
- with a 72 hour advanced notice, visits can occur from one to a couple of hours;
- once the three visits have occurred, the parties will transition to the Respondent having visits in his home with the first visit being a three hour visit on a Saturday, the second visit being a six hour visit on a Saturday, the third will be an eight hour visit on a Saturday and the fourth one will be a Friday at 5 pm, overnight to Saturday at 5 pm; thereafter the schedule will go to standard parent-time;
- due to the Respondent's work schedule, counsel will coordinate the every other weekend visits;
- for at least six months, the Respondent will notify the Petitioner at least 72 hours in advance if he will be exercising his parent-time;
- if the Respondent is consistently notifying and showing up to exercise his parent-time, the Petitioner will drop the 72 hour advanced notice;
- if the Respondent is going to be late, he should send the Petitioner a text; if he no shows or cancels the same day, that will re-set the six month period of time; if the Respondent does not show up for 30 minutes after
- if the Respondent does not show up for 30 minutes after the scheduled parent-time, he forfeits the entire weekend; - if the Respondent's consistently does the seven visits within the next six weeks to two months period of time, the schedule will go to standard parent-time; if he fails to, the seven visits will start all over again;
- the Respondent will not have the child around anybody who is a convicted felon, drug or sex offender;
- counsel will coordinate a calendar based upon the Respondent's work schedule.

After verifying the parties agree to the terms of the partial stipulation, Commissioner T Patrick Casey APPROVES the partial stipulation.

Counsel argue the remaining issues.

Following argument and review of the file, Commissioner T Patrick Casey RECOMMENDS:

- 1. the partial stipulation should be implemented into the appropriate order to be prepared by counsel for the Petitioner;

04-06-2020 Ruling Entry - COVID-19 NOTICE OF CONTINUANCE

In accordance with the current Utah Supreme Court Administrative Order for Court Operations During Pandemic, the April 14, 2020 Review Hearing is considered non-critical, and therefore is continued without date, and without prejudice. The commissioner notes that on December 24, 2019 a Stipulation was filed in which the parties agreed upon a parent-time schedule through the end of 2020.

The parties may contact the commissioner's team to obtain a new hearing date, but at this time it is unknown whether rescheduled dates will again need to be continued. The situation is fluid and continually being reassessed. These extraordinary circumstances also have led to significant court staff reductions, which has affected the ability to timely respond to requests to reschedule. The Court will respond as soon as possible.

This also might be a case that is ripe for certification. If so, the parties are encouraged to discuss the case, and if possible to submit a 'Stipulated Order of Issues Certified for Trial' for the commissioner's signature, which may obviate altogether the need for a pretrial conference before the commissioner.

In addition, absent agreement otherwise, until restrictions are lifted and matters can be considered on the merits any existing orders remain in effect and the parties should adhere to the following pandemic guidelines. The parties also should attempt to mediate the issues, if possible, using appropriate social distancing measures, such as teleconferencing, in an attempt to reach global resolution.

REGULAR PARENT-TIME: There should be no deviation from the normal parent-time schedule unless the child or someone in the child's home has tested positive for COVID-19 or the child is under order to quarantine. If that is the case, the verification of the directive shall be provided to the other parent within 24 hours, and parent-time exchanges should be suspended for a period of two weeks.

Likewise, if a parent without the child, or someone in their home tests positive or is under order to quarantine,

they should immediately inform the other parent, and parent-time exchanges should be suspended for a period of two weeks.

During the period of suspended parent-time, the parent without the child shall have at least 30 minutes of virtual parent-time (Google Hangouts, Skype, Facetime, etc.) each day. The missed parent-time will be made up during the summer break, or at other times agreed upon by both parents. If a child remains positive or under quarantine order after the conclusion of the two week period, this provision should be extended until the child is no longer positive or subject to quarantine.

PARENT-TIME EXCHANGES: To the extent possible, social-distancing guidelines should be adhered to during parent-time exchanges.

RIGHT OF FIRST REFUSAL: If the governing order allows for the right of first refusal to provide child care, the fact that a child may not be attending school does not affect the order.

SCHOOL CLOSURES: School closures due to the pandemic should NOT be treated as snow days, teacher development days, or other days when school is not scheduled under Utah Code 30-3-35 (b)(iv) and (c). Until the conclusion of the academic year, children should be returned to the other parent at the time they normally would be delivered to school or the other parent as if school were in session.

BE HEALTHY: Comply with all CDC and local and state guidelines and model good behavior for children with intensive hand washing, wiping down surfaces and other objects that are frequently touched, and maintaining social distancing. This also means BE INFORMED. Stay in touch with the most reliable media sources and avoid the rumor mill on social media.

BE MINDFUL: Be honest about the seriousness of the pandemic but maintain a calm attitude and convey to your children your belief that everything will return to normal in time. Avoid making careless comments in front of the children and exposing them to endless media coverage intended for adults. Don't leave the news on 24-7, for instance. But, at the same time, encourage your children to ask questions and express their concerns and answer them truthfully at a level that is age-appropriate.

BE COMPLIANT: Be compliant with court orders and custody agreements. As much as possible, try to avoid reinventing the wheel despite the unusual circumstances. The custody agreement or court order exists to prevent endless haggling over the details of timesharing.

BE CREATIVE: At the same time, it would be foolish to expect that nothing will change when people are being advised not to fly and vacation attractions such as amusement parks, museums and entertainment venues are closing all over the US and the world. In addition, some parents will have to work extra hours to help deal with the crisis and other parents may be out of work or working reduced hours for a time. Plans will inevitably have to change. Encourage closeness with the parent who is not going to see the child through shared books, movies, games and FaceTime or Skype.

BE TRANSPARENT: Provide honest information to your coparent about any suspected or confirmed exposure to the virus, and try to agree on what steps each of you will take to protect the child from exposure. Certainly both parents should be informed at once if the child is exhibiting any

possible symptoms of the virus.

BE GENEROUS: Try to provide makeup time to the parent who missed out, if at all possible. Family law judges expect reasonable accommodations when they can be made and will take seriously concerns raised in later filings about parents who are inflexible in these highly unusual circumstances.

BE UNDERSTANDING: There is no doubt that the pandemic will pose an economic hardship and lead to lost earnings for many, many parents, both those who are paying child support and those who are receiving child support. The parent who is paying should try to provide something, even if it can't be the full amount. The parent who is receiving payments should try to be accommodating under these challenging and temporary circumstances.

For situations not specifically addressed above, the Court hopes and expects parents to be reasonable to try to work together and follow government guidelines to ensure the health and safety of their children, themselves and others. Should parents attempt to take improper advantage of pandemic restrictions, this could result in the imposition of sanctions when full court operations resume. Adversity can become an opportunity for parents to come together and focus on what is best for children. For many children, the strange days of the pandemic will leave vivid memories. It's important for every child to know and remember that both parents did everything they could to explain what was happening and to keep them safe.

This document shall serve as the Order of the Court. No further drafting is necessary.
