

Map

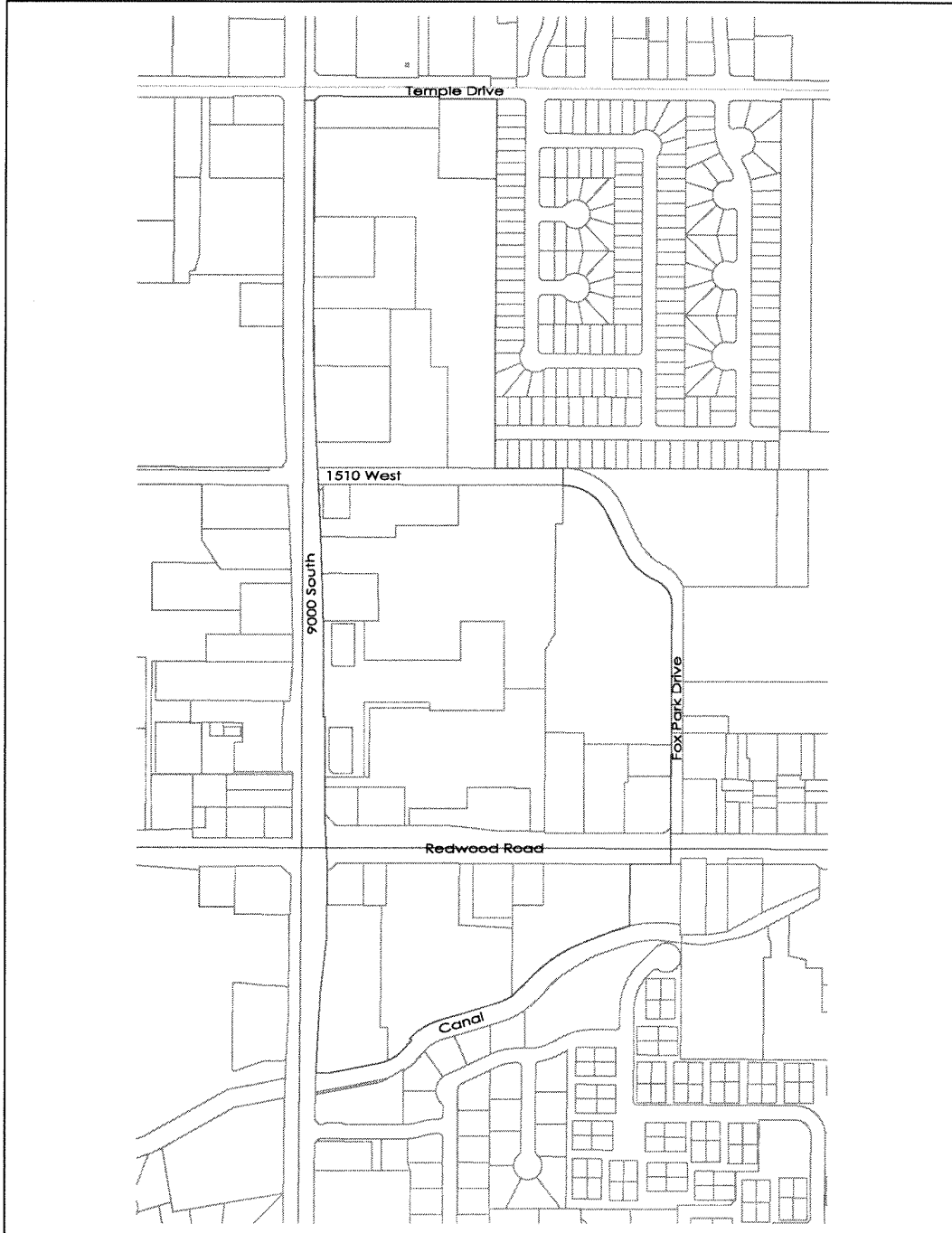
