The UNITED STATES OF AMERICA, Grantor, acting by and through the Acting Chief, Forest Service, Department of Agriculture, heretofore duly authorized by the provisions of the Act of August 14, 1958 (Public Law 85-632, 72 Stat. 588), and the Delegation of Authority and Assignment of Functions by the Secretary of Agriculture dated December 24, 1953 (19 Fed. Reg. 74) and the Delegation of Authority by the Chief, Forest Service, dated May 1, 1959 (24 Fed. Reg. 3767), the provisions of which have been complied with, in consideration of the conveyance to the United States of 2.83 acres, more or less, situated in Utah County, State of Utah, by deed dated January 30, 1960, and recorded in the records of Utah County, Utah, on February 10, 1960, in Book 835 of Records, pages 58-59, the receipt of which is hereby acknowledged, and compliance with the provisions of Section 2 of the said Act of August 14, 1958 (72 Stat. 588), hereby quitclaims to THE PLEASANT GROVE SECOND CORPORATION OF THE CHURCH OF JESUS CHRIST OF LATTER-DAY SAINTS, a Corporation Sole of the State of Utah, Grantee, a parcel of land heretofore known as the Pleasant Grove Administrative Site, Uinta National Forest, situate in the County of Utah, State of Utah, and more particularly

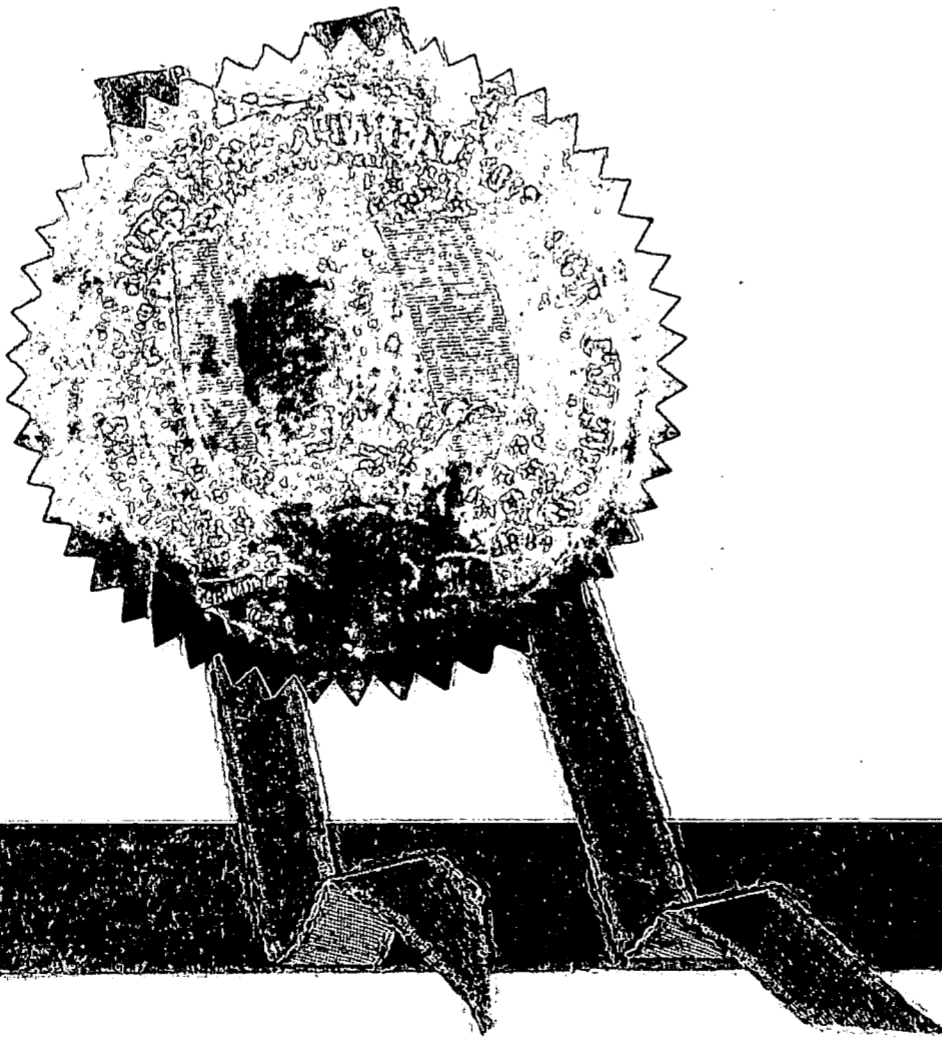
