The foregoing is a correct abstract of judgment rendered in this agency in this action, and no appeal from the judgment has been taken.

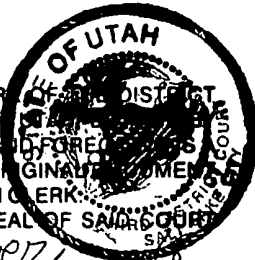


