

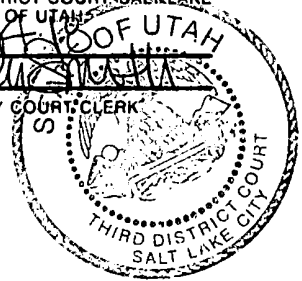

Defendants, Daniel Shapiro and Amber Shapiro, have failed to plead or otherwise defend in this action and default has been entered.

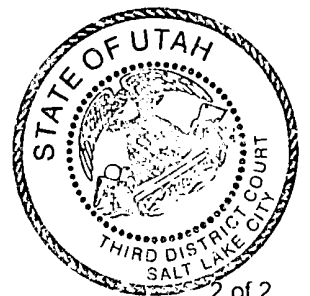
