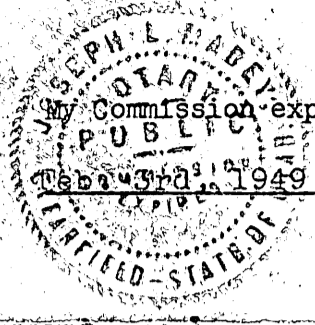

RIGHT OF WAY GRANT

Alton Carlisle and Beryl Carlisle, his wife, Grantors, of

Utah County, State of Utah, do

hereby convey and warrant to MOUNTAIN FUEL SUPPLY COMPANY, a corporation of the State of Utah, Grantee, for the sum of THIRTY-FIVE AND NO/100-----Dollars, (\$35.00), receipt of which is hereby acknowledged, a right of way and easement sixteen (16) feet in width to lay, maintain, operate, repair, remove and replace pipe lines, gates and gate-boxes for transportation of gas and to erect, maintain, operate and remove telegraph and telephone lines through and across the following described land and premises in Utah County, State of Utah, to-wit:

The N E 1/4 of the N E 1/4 of Sec. 25 T. 4 S. R. 1 E. S. 1. B. & M.

the center line of which said right of way shall extend through and across the above described land and premises as follows, to-wit:

Beginning at a point 40.0' ft. more or less South and 170.0' ft. more or less East of the N W. Corner of the N E 1/4 of the N E 1/4 of said Sec. 25; thence S. 36° 11' E. 400.0' ft. more or less to a point 375.0' ft. more or less South and 395.0' ft. more or less East of the N W. corner of the N E 1/4 of the N E 1/4 of said Sec. 25, and beginning at a point 730.0' ft. more or less South and 635.0' ft. more or less East of the N W corner of the N E 1/4 of the N E 1/4 of said Sec. 25, thence S. 36° 11' E. 360.0' ft. more or less to a point 1020.0' ft. more or less South and 835.0' ft. more or less East of the N W corner of the N E 1/4 of the N E 1/4 of said Sec. 25.

TO HAVE AND TO HOLD the same unto the said Mountain Fuel Supply Company, its successors and assigns forever, with the right of ingress and egress to and from said right of way to maintain, operate, repair, remove and replace the same or any part or parts thereof. The said Grantor s to fully use the said premises, except for the purposes for which this right of way and easement is granted, provided such use does not interfere with the rights granted to Grantee hereunder. The Grantor s, shall not build or construct nor permit to be built or constructed any building or other improvement over or across said right of way.

The Grantee hereby agrees to pay damages which may arise to crops or fences from the laying, erecting, maintaining, operating or removing of said pipe lines, gates or gate-boxes or telegraph and telephone lines; said damages, if not mutually agreed upon, to be ascertained and determined by three disinterested persons, one thereof to be appointed by Grantor s, one by the Grantee, and the third by the two so appointed. Should more than one pipe line be laid under this grant at a

125- subsequent time, Grantee agrees to pay to Grantors, damages which may arise to crops or fences resulting therefrom, to be determined, if not mutually agreed upon as above provided.

This right of way grant shall be binding upon and enure to the benefit of the executors, administrators, heirs and assigns of the Grantors, and the successors and assigns of the Grantee.

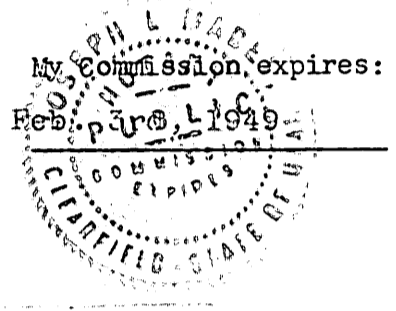
