KNOW ALL MEN BY THESE PRESENTS:

THAT Mountain Fuel Supply Company, a Utah corporation, does hereby release, surrender and abandon unto the lessor or lessors named and described on Exhibit "A" which is attached hereto and by this reference made a part hereof, his/her or their successors and assigns, all its right, title and interest in and to each oil and gas lease situate in the following described lands, to-wit:

Township 2 North, Range 5 East, Salt Lake Meridian,
Summit County, Utah;

Section 4: SE $\frac{1}{2}$ SE $\frac{1}{2}$;

Section 9: E $\frac{1}{2}$, NE $\frac{1}{2}$ SE $\frac{1}{2}$ NW $\frac{1}{2}$, S $\frac{1}{2}$ SE $\frac{1}{2}$ NW $\frac{1}{2}$, E $\frac{1}{2}$ SW $\frac{1}{2}$;

Section 10: W $\frac{1}{2}$ W $\frac{1}{2}$, W $\frac{1}{2}$ E $\frac{1}{2}$ SW $\frac{1}{2}$;

Said leases are more fully described in Exhibit "A."

Said release excepts and reserves unto Mountain Fuel Supply Company, all oil and gas and gas storage rights in the Coalville Gas Storage Project which is a zone between the surface and 4,000 feet below the surface or its stratigraphic equivalent as measured by the Coalville Gas Storage Well No. 1 (also commonly known as the J. D. Wilde Well No. 1), located in Section 9, of Township 2 North, Range 5 East, S.L.M., Summit County, Utah.

Each lessor is hereby given all such surface rights as do not interfere with lessee's retained right to drill, install, construct, maintain, operate and remove wells, pipelines and other facilities reasonably necessary or convenient to its gas storage rights; and all sub-surface rights, other than the sub-surface rights hereby excepted and reserved between the said stratigraphic zone of the surface and 4,000 feet below the surface of each lease,

and lessor is hereby further given the right to drill through, install casings and other structures within and use the area of said gas storage reservoir so long as such use does not interfere with the injection, storage and removal of natural gas from said reservoir by lessee, Mountain Fuel Supply Company.
