

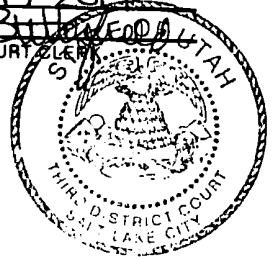

- For plaintiff's cost incurred herein in the sum of \$220.00.

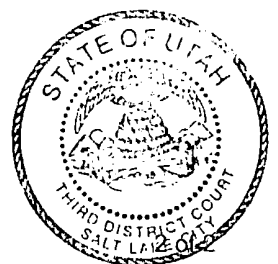
The total Judgment of \$7,937.48 shall bear interest at the rate of 3.76% per annum until
