ADDENDUM No. 1 TO COOPERATION AGREEMENT

This Addendum No. 1 to Cooperation Agreement is entered into effective this day of march, 2019, by the Metropolitan Water District of Salt Lake & Sandy ("District") and Draper City ("City").

ADDENDUM PURPOSES

District owns and operates the Salt Lake Aqueduct ("SLA") and SLA Corridor ("Aqueduct Corridor") and certain improvements located within or on the Aqueduct Corridor. District is a subdivision of the State of Utah responsible for transporting and treating public water, and as such District has regulatory authority to protect the Aqueduct, Aqueduct Corridor, District improvements and operations, and District water.

City is currently using District's Aqueduct Corridor pursuant to a Cooperation Agreement ("Agreement") between District and City dated August 28, 2012, and recorded August 29, 2012 as Entry 11460100, Book 10050, Pages 5837 to 5867 in the records of the Salt Lake County Recorder, Application No. S-09-1078.

NOW, THEREFORE, in consideration of the mutual covenants described in the Agreement as amended by this Addendum, the parties hereby amend the Agreement as follows:

1. City desires to add new and improve existing trails to its public, non-motorized trail system across portions of the SLA Corridor, including the Rush Trail Extension, Edelweiss Trails, and Lower Corner Canyon Hub.

In accordance with the Agreement, City has submitted to District a written request to extend the trails. No changes are proposed to the maintenance and security plans.

Improvements to existing trails and new trails shall be maintained in compliance with the Agreement.

2. Paragraph III(D) of the Agreement entitled "Location by Stationing" shall be replaced with the following:

SLA Station 1311+48 to 1531+88.34.

3. City's contact under Paragraph XIX of the Agreement entitled "Notices" shall be replaced with the following:

Exhibit A SLA Corridor Legal Description(s)

City's use of the SLA Corridor shall be expanded to include those portions of the SLA Corridor shown on the drawings attached as Exhibit B. City's trail use previously included portions of SLA Tracts 407B, 407, 406, 405, 404, 403, 402, 401, 400, 349B, and 349A. City's use is expanded to include an additional portion of Tract 349A and a portion of Tracts 348B and 348A.

Tract 348A and B (Fee):

A strip of land 50 feet wide and included between two lines extended to the property lines and everywhere equally distant 25 feet on each side of that portion of the following described center line known as the Alpine-Draper Tunnel between Station 86+60.5 to Station 114+90.2 measured at right angles thereto; said center line is more particularly described as follows:

Beginning at Station 86+60.5 a point on the South line of the Grantors' property in the Southwest Quarter of Section 10, T. 4 S., R. 1 E., S.L.B. & M. from which point the NW corner of said Section 10 bears North 5078.2 feet and West 2667.8 feet; thence N. 30°30' W. 2829.7 feet to Station 114+90.2 a point on the North line of the Grantors' property from which point the NW corner of said Section 10 bears N. 2640 feet and West 1231.6 feet.

Containing 3.25 acres, more or less.

Tract 349A (Fee):

A strip of land 50 feet wide and included between two lines extended to the property lines and everywhere equally distant 25 feet on each side of that portion of the following described center line known as the Alpine-Draper Tunnel between Station 114+90.2 to Station 145+54.2 measured at right angles thereto; said center line is more particularly described as follows:

Beginning at Station 114+90.2 a point in the NW quarter of Section 10 and the NE corner of Section 9, all in Township 4 South, Range 1 East, SLB&M, from which point the NW corner of said Section 10 bears North 2640 feet and West 1231.6 feet; thence North 30°30' West 3064.0 feet to Station 145+54.2 from which point the NE corner of said Section 9 bears East 323.5 feet.





Exhibit B New Draper Trails


