COLLATERAL

To secure to Secured Party, the repayment of the Indebtedness, and all renewals, extensions and modifications thereof, and the performance of the covenants and agreements of Debtor contained in the Loan Documents, Debtor hereby pledges, assigns, and grants to Secured Party a continuing security interest in the Deed of Trust Property.
