CONVEYANCE OF PROPERTY AND EASEMENT

The NORTH UNION IRRIGATION COMPANY, of Utah County, Utah, Grantor, for good and valuable consideration, receipt of which is hereby acknowledged does hereby grant and warrant to the UTAH WATER AND POWER BOARD, its heirs, administrators, successors, and assigns, the right to erect, install, operate and maintain a concrete lined irrigation canal with appurtenant structures, upon, over or across the following described land owned by the Grantor, lying in Utah County, Utah, together with the right of ingress and egress thereto and therefrom:

A strip of land 50 feet wide, the centerline of which begins at Twelfth North Street, Orem, Utah, at a point which is East 820 feet from the Southwest Corner of Section 2, T6S, R2E, SL&M; and running thence N 06°40' E, 210 feet; N 04°40' W, 310 feet; N 11°20' W, 320 feet; N 16°10' W, 595 feet; N 10°00' W, 585 feet; N 25°11' W, 990 feet.

The Grantor also hereby conveys to the Grantee, the full use of its entire irrigation system located in the following Sections of land in Utah County, Utah: Sections 12, 13, 14, 2, and 3, T6S, R2E, and Section 34, 27, and 28, T5S, R2E, SL&M.

The Grantor also hereby conveys, grants and warrants to Grantee all of Grantor's right and interest to 700 shares of Provo Bench Canal and Irrigation Company's stock and the water and water rights represented by such stock, the stock being designated by the following numbered certificates of the Provo Bench Canal and Irrigation Company, now held in the Treasury of the North Union Irrigation Company.
