ADDENDUM THREE TO THE DECLARATION OF

FOR BRIDLEWOOD COURT TOWNHOMES P.U.D.

This Addendum Three is made to the Declaration of Covenants, Conditions, and Restrictions (CC&R's) for Bridlewood Court Townhomes P.U.D. dated December 29, 2014.

- 1. <u>Consent of Owners</u>: This Amendment has been made and consented to by Owners representing more than 51% of the Lots within Bridlewood Court Townhomes P.U.D. during the October 14, 2019 Annual Meeting, via secret ballot.
- 2. <u>Amendment</u>: 12.3(c) of Article 12: Leases. Except for Lot 17, which is grandfathered under the original CC&R's dated December 20, 2014, and until which time the Lot is sold or the homeowner ceases its leasing status, this article is hereby retracted and restated as follows:
- 12(c) of Article 12: Leases. The leasing, renting, letting and licensing of Lots within the Bridlewood Homeowners Association are prohibited. Bridlewood Court Townhomes P.U.D. will endorse and compile with Utah Code 57-8a 209 Rental Restrictions.
- 3. In all other respects, the Bridlewood Court Townhomes P.U.D. CC&R's shall remain in full force and effect.
