NOTICE OF REINVESTMENT FEE COVENANT

(Scottbrook Condominium)

Pursuant to Utah Code §57-1-46(6), the Scottbrook Condominium Owners Association, Inc. ("Association") hereby provides this Notice of Reinvestment Fee Covenant which burdens all of the real property described in Exhibit A (the "Burdened Property"), attached hereto. The burdened property is subject to the "Amended Scottbrook Condominium Declaration of Covenants, Conditions and Restrictions" as recorded with the Salt Lake County Recorder on November 14, 1980, as Entry No. 3502893, as amended and supplemented (the "Declaration"), which authorizes the Association's reinvestment fee.
