- 4. <u>Conflicts</u>. All remaining provisions of the Declaration and any prior amendments not specifically amended in this Amendment shall remain in full force and effect. In the case of any conflict between the provisions of. This document and the provisions of the Declaration or any prior amendments, the provisions of this Amendment shall in all respects govern and control.
- 5. <u>Incorporation and Supplementation of Declaration</u>.
