In that event, the Lender will have all of the rights and remedies provided by the Loan Documents.
 - B. The Loan Documents will not be modified unless and until (i) the Lender accepts this Agreement by signing and returning a copy of it to me, and (ii) the Modification Effective Date, as set fourth in Section 3, has occurred. I further understand and agree that the Lender will not be obligated or bound to make any modification of the Loan Documents if I fail to meet any one of the requirements under this Agreement.
- 3. The Modification. If my representations and covenants in Section 1 continue to be true in all material respects and all preconditions to the modification set forth in Section 2 have been met, the Loan Documents will automatically become modified on 02/01/2021 (the "Modification Effective Date") and all unpaid late charges that remain unpaid will be waived. I understand that if I have failed to make any payments as a precondition to this modification under a Trial Period Plan, this modification will not take effect.  - A. The Maturity Date will be 11/01/2047.
 - B. The modified principal balance of my Note will include all amounts and arrearages that will be past due as of the Modification Effective Date (including unpaid and deferred interest, fees, escrow advances and other costs, but excluding unpaid late charges, collectively, ("Unpaid Amounts") less any amounts on the Lender but not previously credited to my Loan. The Unpaid Amounts include \$99,783.82 of unpaid interest, \$11,970.88 of advanced escrows, \$7,792.50 of legal fees, \$1,016.10 of other fees, and \$474.40 of pending fees. The new principal balance of my Note will be \$1,103,008.76 (the "New Principal Balance").
