  - B. This Amendment clarifies what is included I the Common Area and Facilities.

NOW, THEREFORE, Declarant hereby declares and provides as follows:

- 1. <u>Declaration Incorporated by Reference.</u> The Declaration, and any amendments thereto, are hereby incorporated by reference and made a part of this Amendment as though fully set forth herein.
- 2. <u>Revision to Section III(1).</u> Section III(1) of the Declaration is hereby deleted and replaced with the following language:

Description of Improvements. The significant improvements contained or to be contained in the Project include a single Phase I which will consist of 28 Units. The Units will be constructed principally of concrete foundations with exterior walls of stone, stucco veneer, vinyl or wood composition siding, asphalt shingle roofing, interior walls of wood studs, plywood, and dry wall plaster. Each Unit has been or will be assigned a garage, covered parking space, or uncovered parking space. The Common Area and Facilities will include green space, landscaping, roadways, walkways, and utility systems, as well as an entrance to and exit from the Community. The Project will also contain other improvements of a less significant nature. The location and configuration of the improvements referred to in the foregoing sentence are depicted on the survey Map.

3. <u>Effective Date.</u> This Amendment shall be effective upon recording in the Office of the Salt Lake County Recorder. Except as herein expressly provided, the Declaration shall remain in all other respects unmodified and in full force and effect.
