ORDERED, ADJUDGED AND DECREED that Plaintiff shall have a Judgment against Defendant, Jerry Krambule, as follows:

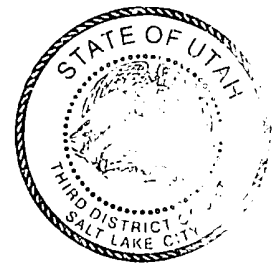
1. For Judgment in the principal sum of \$13,140.78.
