

WHEREFORE, by virtue of the law, and by reason of the aforesaid,

IT IS HEREBY ORDERED, ADJUDGED AND DECREED that Plaintiff be awarded judgment against Defendant, Robert Young, as follows:

\$18,105.81 Principal,
338.55 Accrued interest from September 5, 2015 to January 13, 2016 at 5.25% per annum,
488.00 Accrued costs, and
1,204.75 Attorney's fees,

\$20,137.11 TOTAL JUDGMENT,

with interest accruing on the Total Judgment from January 13, 2016 at the rate of 5.25% until paid in full.

Furthermore, the Utah Division of Motor Vehicles is HEREBY ORDERED to disclose all motor vehicle records pertaining to Defendant, or information pertaining to Defendant in connection with a motor vehicle record, for the purpose of assisting Plaintiff in executing, enforcing, or collecting this Judgment.

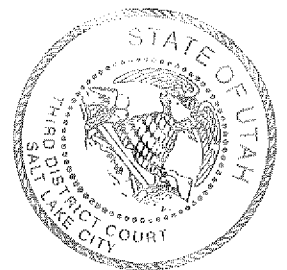
