ORDER AND RESOLUTION

WHEREAS, what is known and described as Plats "C" and "D" of the Steel City Subdivision of Provo City, Utah County, Utah, was heretofore duly platted and designated as such by the Board of Commissioners of Provo City, and the dedication of the streets and alleys thereof were duly dedicated to Provo City, which dedication Provo City duly accepted, and

WHEREAS, the major portion of said lands are owned by the estate of F. W. C. Hathenbruck deceased, and petition in due form has been duly filed with the Board of Commissioners of Provo City by the executrix thereof seeking the vacation and abandonment of the said Plats "C" and "D" and of the streets and alleys therein contained, and

WHEREAS, said lands are of a poor grade, entirely valueless for farming or at the present, for residence purposes, and

WHEREAS, no streets or alleys have been staked or otherwise marked out upon the ground, and none thereof have ever been used as such by the public or adjoining land owners, and no improvements or buildings have been constructed thereon, and

WHEREAS, the burden of taxes upon the said property as it is now designated are excessive for the character of the said real estate, and cannot be further adjusted until said streets and alleys are vacated, and

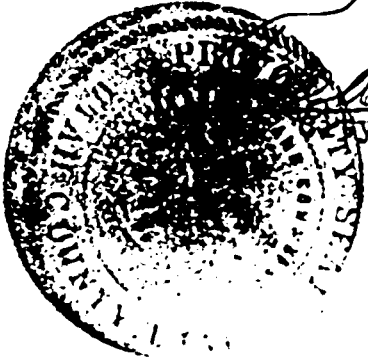
WHEREAS, the major portion of said property is now in the estate of F. W. C. Hathenbruck, deceased, which said estate has no liquid assets and very little income producing property,

NOW, THEREFORE, BE IT RESOLVED, that the certain plats designated as Plats "C" and "D" of the Steel City Subdivision be, and the same are hereby vacated and set aside and the said lands and the whole thereof, restored to and declared to be acreage within

the city and no longer designated as blocks, lots, streets or alleys.

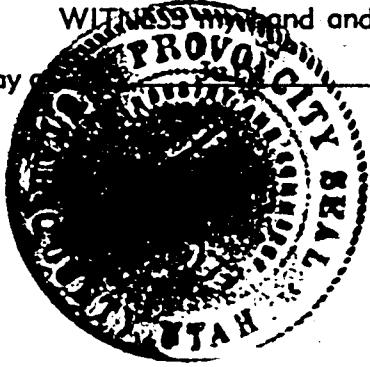
