WHEREFORE, by virtue of the law, and by reason of the aforesaid,

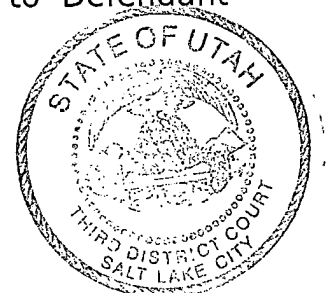

with interest accruing on the Total Judgment from February 15, 2022, at the rate of 18.99% until paid in full.

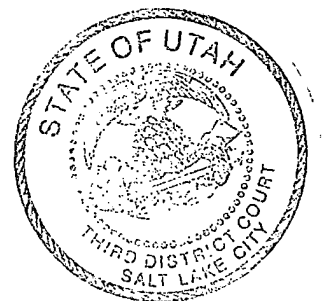
