AMENDMENT OF CONDITIONS AND RESTRICTIONS

The undersigned, being the owners of Lots 1 to 59, inclusive of CHERRY RIDGE, a subdivision in Salt Lake County, Utah, according to the plat thereof recorded in the office of the County Recorder of Salt Lake County, do hereby declare and agree that the second paragraph of the Conditions and Restrictions executed June 17, 1953 by Elbert G. Adamson and Beatrice L. Adamson, his wife, recorded June 18, 1953 as Entry No. 1333948, in Book 1015, page 288 of Official Records, be changed and amended to read as follows:

"2. USE OF LAND: No structures shall be erected, altered, placed or permitted to remain on any residential building plot other than one detached single-family dwelling not to exceed two stories in height and a private garage for not more than two cars, except Lots 43 and 44 upon which lot it shall be permissible to build two-family dwellings not to exceed one story in height and private garages or carports for not more than two cars".
