THIS DEED OF TRUST, ASSIGNMENT OF RENTS, SECURITY AGREEMENT AND FIXTURE FILING (this "Deed of Trust") is made as of July 14, 2022, between **Social Clout Media LLC**, an **Idaho limited liability company**, whose address is 25 Warren Ave, Pocatello, Idaho, 83201, as TRUSTOR, **Kyle Fielding**, whose address is 230 N 1680 E, Suite L2, St. George, UT 84790, as TRUSTEE, and **Diversified Income Strategy Fund**, **LLC**, a **California Limited Liability Company**, whose address is 1695 Oak Lane, Kamas, UT 84036, as BENEFICIARY.

TRUSTOR HEREBY GRANTS, TRANSFERS, CONVEYS, ASSIGNS AND WARRANTS TO TRUSTEE IN TRUST, WITH POWER OF SALE AND FOR THE BENEFIT OF BENEFICIARY, the real property situated in Salt Lake County, State of Utah (known by common address of 266 East Crestone Avenue, South Salt Lake, UT 84115), and more particularly described in **Exhibit A** attached hereto and made a part hereof, together with all buildings, fixtures and improvements thereon and together with all present and future easements and rights used in connection with the real property or as a means of access to the property (the "Land"), and together with all right, title and interest that Trustor now has or may hereafter acquire in (collectively, the "Property"):

- (5) all proceeds and claims arising on account of any damage to or taking of the Property or any portion of the Land, and all causes of action and recoveries for any loss to or diminutions in the value of the Land;

FOR THE PURPOSE OF SECURING (1) payment of the indebtedness evidenced by an Promissory Note (hereinafter the "Note") of even date herewith, in the maximum principal amount of \$325,000.00 made by Trustor and payable to the order of Beneficiary at the times, in the manner and with interest as set forth in the Note, and any modifications of the Note; (2) the performance of each agreement of Trustor contained both in this Deed of Trust and in the Note and all documents related thereto or executed in connection therewith; (3) the payment of such additional loans or advances as may be made to Trustor after the date of this Deed of Trust, whether or not evidenced by a promissory note or notes reciting that they are secured by this Deed of Trust; and (4) the payment of all sums expended or advanced by Beneficiary under or pursuant to the terms of this Deed of Trust, plus interest.

TRUSTOR REPRESENTS, WARRANTS, COVENANTS AND AGREES:

- To keep the Property in good condition and repair; not to remove or demolish any building on the Property; to complete or restore promptly and in good and workmanlike manner any building which may be constructed, damaged or destroyed on the Property; to comply with all laws, covenants and restrictions affecting the Property; not to commit or permit waste of the Property; not to commit, suffer or permit any act upon the Property in violation of law; and to do all other acts which from the character or use of the Property may be reasonably necessary.

- To provide and maintain insurance of such type or types and amounts as are reasonable and customary on the Property, and to have Beneficiary included as a loss payee under such insurance. In the event of loss, Trustor shall give immediate notice to Beneficiary, who may make proof of loss, and each insurance company concerned is hereby authorized and directed to make payment for such

The insurance required by this paragraph shall include, at a minimum, all-risk property insurance and comprehensive general liability insurance in such minimum amounts as Beneficiary may require from time to time. Lender shall not be in any way responsible or liable for the debts, losses, obligations, or duties of Borrower with respect to the Property or otherwise. All obligations to pay impositions, insurance, premiums, and all other amounts owing in respect to the ownership, operation, occupancy, or use of the Property and all agreements, documents and instruments relating to the Property shall be the sole responsibility of Borrower.

All such compensation, awards, damages, rights or action and proceeds, including the proceeds of any policies of fire and other insurance affecting the Property, are hereby assigned to Beneficiary, who may, after deducting therefrom all its expenses, including attorneys' fees, apply the same on any

- (f) any representation, warranty or disclosure made to Beneficiary by Trustor proves to be materially false or misleading on the date as of which made, whether or not that representation or disclosure appears in the Loan Documents; or

- (h) there is a change, modification, or cancellation of insurance coverage that affects the Property without Lender's prior knowledge, and/or without the Lender's written consent.
- 12. Upon the occurrence of any default hereunder, Beneficiary may at any time without notice, either in person, by agent, or by a receiver to be appointed by a court (Trustor hereby irrevocably consenting to the appointment a receiver by a Court of competent jurisdiction), and without regard to the adequacy of any security for the indebtedness hereby secured, enter upon and take possession of the Property or any part thereof, in its own name sue for or otherwise collect said rents, issues and profits, including those past due and unpaid, and apply the same, less costs and expenses of operation and collection, including reasonable attorneys' fees, upon any indebtedness secured hereby, and in such order as Beneficiary may determine.
- 13. The entering upon and taking possession of the Property, the collection of such rents, issues, and profits, or the proceeds of fire and other insurance policies, or compensation or awards for any taking or damages of the Property, and the application or release thereof as aforesaid, shall not cure or waive any default or notice of default hereunder or invalidate any act done pursuant to such notice.
- 14. Upon the occurrence of any default hereunder, all sums secured hereby shall immediately become due and payable at the option of Beneficiary in any manner provided by law for the foreclosure of mortgages, trust deeds, or security agreements.
 - 15. Time is of the essence of this Deed of Trust.
- 16. Upon the occurrence of any default hereunder, Beneficiary shall have the option to declare all sums secured hereby immediately due and payable and foreclose upon the Property in any manner provided by law for the foreclosure of mortgages, trust deeds, or security agreements, and Beneficiary shall be entitled to recover in such proceedings all costs and expenses incident thereto, including reasonable attorneys' fees. No material default will be declared by Beneficiary or its Agents against Borrower unless it has first been subject to a right to cure by Borrower and/or its Trustors. The reasonable right to cure provision requires Beneficiary or its Agents, upon the awareness of any perceived material default under this Agreement, to provide Notice under Section 29 of the specific instance(s) of alleged Default with request for immediate cure and will provide Borrower and/or its Trustors with a five (5) day period to fully cure the Default or provide reasonable explanation of why a material Default did not occur, in whole or in part.
- 17. The right to plead any and all statutes of limitation as a defense to any demand secured by or made pursuant to this Deed of Trust is hereby waived to the full extent permitted by law. Trustor waives any and all rights to redeem the Property from sale under any judgment of foreclosure of this mortgage, on Trustor's behalf and on behalf of all other persons, except judgment creditors of Trustor, who acquire any interest in the Property after the date of this mortgage. - 19. Trustor covenants and agrees that the acceptance by Beneficiary of any sum secured hereby after its due date, or in an amount less than the sum then due, shall not constitute a waiver by Beneficiary of its rights either to require prompt payment when due of all other sums so secured or to declare a default or exercise such other rights as herein provided for failure so to pay. No failure by Beneficiary to insist upon strict performance of any term, covenant or condition hereof, nor failure to exercise any right or remedy hereunder shall constitute a waiver of any such breach of such term, covenant or condition or of the later exercise of such right or remedy.

No remedy herein conferred upon or reserved to Trustee or Beneficiary is intended to be exclusive of any other remedy herein or by law provided or permitted, but each shall be cumulative and shall be in addition to every other remedy given hereunder or now or hereafter existing at law or in equity or by statute.

All obligations of Trustor hereunder are joint and several. The term "Beneficiary" shall mean the owner and holder of the Note. In this Deed of Trust, whenever the context requires, the masculine gender includes the feminine and/or neuter, and the singular includes the plural.
- If any provision hereof should be held unenforceable or void, then such provision shall be deemed separable from the remaining provisions and shall in no way affect the validity of this Deed of Trust except that if such provision relates to the payment of any monetary sum, then, Beneficiary may, at its option declare the indebtedness and all other sums secured hereby immediately due and payable.
- It is the intention of Trustor and Beneficiary to conform strictly to the usury laws now or hereafter in force in the State of Utah, if any, and any interest payable under the Note, this Deed of Trust, and/or any of the other documents or instruments executed by Trustor in connection with the loan made or to be made under the Note shall be subject to reduction to the amount not in excess of the maximum nonusurious amount allowed under the usury laws as now or hereafter construed by the courts having jurisdiction over such matters.
