DECLARATION OF RESTRICTIVE COVENANT

THIS DECLARATION OF RESTRICTIVE COVENANT (this "Covenant") is made this 25th day of May, 2022, by Jefferson Ballpark, LLC, a Utah limited liability company ("Declarant").

RECITALS

 - a. Owning, acquiring, operating, managing, investing in or leasing wireless telecommunications infrastructure.
- 2. <u>Duration.</u> The covenants and restrictions listed herein shall run with and bind the Property, and be binding on the Declarant, its personal representatives, heirs, successors and assigns, unless and until terminated or modified by American Tower. The covenants and restrictions shall automatically terminate upon the expiration or termination of American Tower's lease impacting that certain property commonly known as 150 W. 1400 S.. Salt Lake City, UT APN:15-13-211-009.
- 3. **Recording**. Subsequent to recording of this Covenant, Declarant shall present American Tower with a recorded copy. American Tower shall, within a reasonable timeframe thereafter, submit a release of interest releasing all rights, title, interests and Rights of First Refusal encumbering the Property pursuant to that certain Communication Site Lease Agreement (Ground) dated April 19, 2000 (as may have been amended from time to time).
