 4. Costs: \$480.00
- TOTAL: \$40,793.49

For post-judgment interest to accrue on the principal balance of the judgment at the rate of 12% per annum pursuant to Utah Code section 58-55-603.




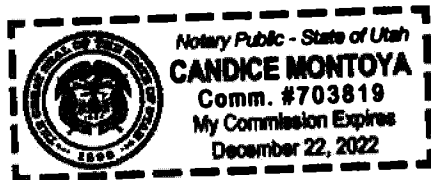
