PARTIAL TERMINATION OF MEMORANDUM OF OPTION AGREEMENT

This PARTIAL ASSIGNMENT OF MEMORANDUM OF OPTION AGREEMENT (this "<u>Termination</u>") is made and entered into as of March <u>30</u>, 2023, by GARDNER WEST JORDAN, L.C., a Utah limited liability company ("<u>Buyer</u>"), and M H JONES FAMILY, LLC, a Utah limited liability company ("<u>Seller</u>").

WITNESSETH:

- A. - 2. <u>Counterparts</u>. This Termination may be executed in counterparts, each of which shall be deemed an original, but all of which, taken together, shall constitute one and the same instrument.
- 3. <u>Captions</u>. Captions used in this Termination are for convenience of reference only and are not intended to govern, limit, or aide in the construction of any term or provision hereof.

4. <u>Governing Law.</u> This Termination shall be governed by the laws of the State of Utah.


