- B. The Master Declaration reserves to the Declarant the right and authority to unilaterally expand the Project in accordance with the Master Declaration.
- C. Declarant is the record owner of certain real property located in Magna, Salt Lake County, Utah, more fully described herein (the "Property" or "Gabler's Grove Phase 4").
- D. Declarant desires to further expand the Project to include an additional twenty-two (22) Lots, and other improvements of a less significant nature on the Property.
- E. Declarant now intends that the Property and the Lots thereon shall become part of the Project and subject to the Master Declaration.
- **NOW, THEREFORE**, for the reasons recited above, and for the benefit of the Project, Declarant, and Owners, Declarant hereby executes this Supplement to the Master Declaration of Covenants, Conditions, and Restrictions for Gabler's Grove for Gabler's Grove Phase 4.

SUPPLEMENT TO MASTER DECLARATION

- 1. <u>Supplement to Definitions</u>. Article I of the Master Declaration, entitled "Definitions," shall be and hereby is modified to include the following supplemental definitions:
 - "Gabler's Grove Phase 4 Plat" shall mean and refer to the final plat maps of the Property that have been or will be recorded with the Office of County Recorder for Salt Lake County, Utah contemporaneous with the filing of this Supplement to Master Declaration.

Except as otherwise provided herein, the definitions of capitalized terms contained in the Master Declaration are incorporated herein by this reference.

- 2. <u>Annexation</u>. Consistent with the rights and authority reserved to Declarant in the Master Declaration, the Property shall be and hereby is annexed into the Project and the Gabler's Grove Master Association, which is organized and operating as a Utah nonprofit corporation (the "Master Association"). Recordation of this Supplement to Master Declaration, together with the Gabler's Grove Phase 4 Plat, shall constitute and effectuate further expansion of the Project, making the real property described in Exhibit A and every Owner and Occupant of a Lot thereon subject to the Master Declaration and the functions, powers, rights, duties, and jurisdiction of the Master Association.
- 3. <u>Covenants, Conditions, and Restrictions to Run with the Land</u>. The Covenants, Conditions and Restrictions for the Property and the Lots thereon established by this Supplement to Master Declaration are intended to and shall be binding on the Lots, the respective Owners and their successors in interest and shall run with the land.
