AMENDMENT #IV

TO DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS OF COURTYARD LEISURE HOMES, A PLANNED UNIT DEVELOPMENT

The undersigned, being the president and secretary, respectively, of Courtyard Leisure Homes

Owners' Association, certify as follows:

- 1. The Declaration of Covenants, Conditions and Restrictions of Courtyard Leisure Homes, a Planned Unit Development, dated September 8, 1995 (the "Declaration"), was recorded in the office of the Utah County Recorder September 8, 1995, as Entry No. 59925 in Book 3763 at Pages 340-355. The Declaration involves that certain real property (the "Planned Unit Development") more fully described on Exhibit "A" attached hereto and included herein by reference.
- 2. Pursuant to Article XI, Section 4 of the Declaration, at a meeting duly held upon due notice to all owners within the Planned Unit Development, and pursuant to a vote of at least 67% of the owners, the following amendment to the Declaration was adopted on Declaration (2004):

Article VIII, Section 14 is amended and restated in its entirety as follows:

14. No Rentals or Leases. No townhome may be used or occupied as a rental property or for rental purposes, except that: (a) the owner of a townhome which has a lease or rental agreement in effect as of the date of adoption of this Amendment, may continue to lease or rent that townhome as long as that owner owns record title to the townhome; and (b) an owner may lease or rent that owner's townhome during the period of the owner's absence from the townhome, for up to twenty-two (22) months, upon a showing by

the owner to the Trustees that the Owner has a bona fide and good faith intent to return and to occupy the townhome as the owner's residence.

3. Except as specifically amended herein, all other provisions of the Declaration shall continue in full force and effect.
