AMENDED NOTICE OF REINVESTMENT FEE COVENANT

(The Cottages at the Rose Gardens Phases 1, 2, & 3)

(the "Association") hereby provides this Amended Notice of Reinvestment Fee Covenant which burdens all of the real property described in Exhibit A (the "Burdened Property"), attached hereto. Phase 1 within the Burdened Property is subject to the "Declaration of Covenants, Conditions, and Restrictions of The Cottages at The Rose Gardens", recorded with the Salt Lake County Recorder on August 15, 2008 as Entry No. 10501011, and Phases 2 and 3 within the Burdened Property are subject to the "Declaration of Covenants, Conditions, and Restrictions of The Cottages at The Rose Gardens Phase 2", recorded with the Salt Lake County Recorder on January 25, 2010 as Entry No. 10501011, as either are amended or supplemented, (the "Declaration"). This notice amends and supersedes any previous Notice of Reinvestment Fee Covenant that has been recorded against the Burdened Property.

The Declaration authorizes and the Association agreed to a Reinvestment Fee Covenant that authorizes the Association to assess a reinvestment fee. The Reinvestment Fee Covenant requires, among other things, that upon the transfer of any of the Burdened Property subject to the Declaration, the transferee, is required to pay a reinvestment fee as established by the Association's Board of Directors, unless the transfer falls within an exclusion listed in Utah Code §57-1-46(8). In no event shall the reinvestment fee exceed the maximum rate permitted by applicable law.

BE IT KNOWN TO ALL OWNERS, SELLERS, BUYERS, AND TITLE COMPANIES owning, purchasing, or assisting with the closing of a Burdened Property conveyance within The Cottages at the Rose Gardens Phases 1, 2, & 3 that:
