

Section 1. Identification of Family

- 1.01 My wife's name is GLENADELE N. MÁTÉ. All references in this Will to my wife or my spouse, whether or not specifically named, are to her.
- 1.02 The names of my children now living are CINDY M. CATLETT of White Salmon, Washington, and LINDA M. LARSEN of Hailey, Idaho. All references in this will to "my children" shall mean these children and any other children subsequently born to or lawfully adopted by me. I have no deceased children. MARCUS COLLECTION

Section 2. Nomination of Personal Representative

- 2.01 I hereby nominate GLENADELE N. MATÉ to serve as my personal representative. Should this person be unable or unwilling at any time to serve as my personal representative. I nominate CINDY M. CATLETT to serve as my personal representative. Should this person, be unable or unwilling at any time to serve as my personal representative, I nominate LINDA M. LARSEN to serve as my personal representative.
- 2.02 I direct that my personal representative, and any successor thereto, be permitted to serve without bond.

Section 3. Omission of Spouse and Children

3.01 I have intentionally omitted making direct provisions for my spouse and my children in this will (except for the contingent provisions in paragraph 5.03 of this will) because they are provided for in the trust described in paragraph 5.02 of this will.

Section 4. Disposition of Tangible Personal Property

4.01 If I have prepared a written statement or list in my own handwriting or which I have signed, of certain items of tangible personal property not otherwise specifically disposed of by this will, I direct that such items shall be given to the persons indicated on the list to receive them.

Section 5. Residuary Devise

- 5.01 The balance of my residuary estate shall consist of all real and personal property or money owned by me at the time of my death and not otherwise effectively disposed of in this will, including all insurance proceeds or other death benefits that are payable to my estate.
- 5.02 I give, devise and bequeath the balance of my residuary estate to the then acting Trustee of the revocable trust known as **THE MÁTÉ FAMILY REVOCABLE LIVING TRUST AGREEMENT** and any lawful amendments thereto.
- 5.03 If the balance of my residuary estate cannot be distributed as provided in paragraph 5.02 above either because the trust has been revoked or for any other reason, I give, devise and bequeath the balance of my residuary estate as follows:
 - (1) To my wife, Glenadele N. Máté, if she survives me.

- 6.01 My personal representative, and any successor thereto, shall have all of the powers granted to personal representatives and fiduciaries under the probate code and other applicable laws of the State of Montana, including the power to execute any joint or individual tax return on my behalf or on behalf of my estate.
- 6.02 My personal representative shall be entitled to reasonable compensation for services actually performed and to reimbursement of expenses properly incurred.
- 6.03 My personal representative shall have, in addition to any other powers, the power to invest, reinvest, sell, mortgage, lease or otherwise transfer or dispose of any part or all of my estate, without the necessity of obtaining prior or subsequent court approval.

6.04 My personal representative may make distributions either in cash or in kind. Distributions in kind may be made at the discretion of my personal representative. My personal representative may make any distributions under this will either (1) directly to the beneficiary, (2) in any form allowed by the Montana Uniform Transfers to Minors Act, (3) to the beneficiary's guardian, conservator, or care giver for the benefit of the beneficiary, or (4) by direct payment of the beneficiary's expenses.

Section 7. Construction and Definitions

The following rules and definitions shall apply in the construction of this instrument and in the administration of my estate:

- 7.01 Any reference to "child," "children," or "issue," shall be construed as including all persons who are descended from the person referred to under the intestacy laws of the State of Montana, as those laws exist on the date of my death. An adopted child or issue shall be considered as descended from the person referred to only if such child or issue was adopted prior to age 18. A child in gestation who is later born alive shall be considered as a living child throughout the period of gestation. The term "issue" includes "child."
- 7.02 When an interest is given to the issue of a deceased person, distributions shall be made by representation whereunder the issue of the deceased person take and share equally the share of the estate that would have been taken by the deceased person if he or she were alive.
- 7.03 Any reference to my "personal representative" in whatever form refers to the person, persons, or institution then acting as the personal representative of my estate.
- 7.04 If any devisee or other beneficiary under this will dies within 120 days after my death or under such circumstances where there is insufficient evidence in the judgment of my personal representative to determine whether such person has died within 120 days after my death, the devisee or beneficiary shall be deemed to have failed to survive me.

- 5. On the basis of the statements in the application, venue is proper.
- An original, duly executed, and apparently unrevoked will, dated December 7,
 2006, is in the Court's possession.
- 7. Any required notice has been given or waived.
- 8. On the basis of the statements in the application, the will to which the application relates is not part of a known series of testamentary instruments (other than wills or codicils), the latest of which does not expressly revoke the former.
- 9. On the basis of the statements in the application, no personal representative has been appointed in this state or elsewhere.
- 10. On the basis of the statements in the application, neither the will to which the application relates nor any other will of the decedent has been the subject of a previous probate order in this state.
- 11. It appears from the application that the time limit for informal probate and appointment has not expired.
