Judge: ROBERT FAUST

The Court having heard arguments and having read the pleadings on the Motion to Summary Judgment, determines there is no genuine issue of material fact, which prevents the granting of judgment on the guarantee. The Court determines there was no modification of the loan thus permitting the guarantor to avoid his obligation. Evidence was shown that a Notice of a loan modification was prepared and recorded in error by counsel, based on a misunderstanding regarding other loans and that in fact no such loan modification ever occurred. Second, no evidence or information whatsoever was provided of a loan modification, other than the incorrect notice itself, or that counsel's acknowledge of his error was false or incorrect.

The Court grants judgment against the Defendant in the amount due and owing to TTMM under the Note of One Million Two Hundred Thirty-six Thousand Four Hundred Thirty-eight and 36/100 Dollars (\$1,236,438.36), consisting of a principal balance of \$500,000.00 and accrued interest of \$736,438.36. Interest continues to accrue at the contract default rate of 35% from October 15, 2022 until paid in full. Plaintiff is also awarded its reasonable attorney fees established by affidavit and the judgment will be augmented by the same.
