Grantor, BONNEVILLE -ON-THE-HILL COMPANY , hereby QUIT CLAIMS to the a corporation of the State of Utah STATE ROAD COMMISSION OF UTAH, Grantee for the sum of six thousand twenty two and Dollars, the following described tract of land in no/100 County, State of Utah, to-wit: Salt Lake

An undivided one-half interest in and to land for highway known as Project No. FI-120 situated in the $S_{\overline{Z}}^{\frac{1}{2}}$ $S_{\overline{Z}}^{\frac{1}{2}}$ of Section 32, The $S_{\overline{Z}}^{\frac{1}{2}}$ $S_{\overline{Z}}^{\frac{1}{2}}$ of Section 33, and the $S_{\overline{Z}}^{\frac{1}{2}}$ SW4 and the $S_{\overline{Z}}^{\frac{1}{2}}$ SE4 of Section 34, T. 1 N., R. 2 W., S. To enable the grantee to construct and maintain a public highway as an expressway , as contemplated by Chapter 63, Laws of Utah, 1945, the grantor hereby releases and relinquishes to the grantee any and all rights or easements appurtenant to the grantors remaining property by reason of location thereof with reference to said highway, including, without limiting the foregoing, all rights of ingress to or egress from the grantors remaining property contiguous to the lands hereby conveyed, to or from said highway, EXCEPTING And reserving to the grantor, its successors or assigns, the right of access to the nearest roadway of said right of way lines for five 24 foot, three 4 foot, highway over and across both and two 30 foot sections, which said sections center at points directly opposite Highway Engineer's Stations 420+00 (southerly), 436+00 (southerly), 476+16 (southerly), 495+13 (northerly), 536+55 (southerly), 446+33 (northerly), 476+16 (northerly), 536+55 (northerly), 495+25 (southerly), and 496+75 (southerly) respectively.
