The UTAH DEPARTMENT OF TRANSPORTATION, by its duly appointed Director of Right of Way, Grantor, of Salt Lake City, County of Salt Lake, State of Utah, hereby QUIT CLAIMS to Boyer West Jordan Residential, L.C., a Utah limited liability company, as to an undivided 50% interest and Yale Kilgore Investments LLC, a Utah limited Liability company as to an undivided 50% interest, as tenants in common, Grantees, of Salt Lake County, State of Utah, Zip 84114, for the sum of TEN (\$10.00) Dollars, and other good and valuable considerations, the following described tract of land in Salt Lake County, State of Utah, to-wit:

A tract of land situate in the NE1/4NE1/4 of Section 2, T. 3 S., R. 2 W., S.L.B. & M. The boundaries of said tract of land are described as follows:

Beginning at a point in the northwesterly right of way line of the vacated New Bingham Highway, which point is 466.88 ft. S. 00°23'26" E. along the section line and 63.52 ft. S. 57°50'00" W. from the Northeast corner of said Section 2, and running thence S. 00°23'26" E. 79.40 ft.; thence S. 57°50'00" W. 1032.71 ft. to the easterly right of way line and no-access line of the Mountain View Corridor at a point in a 6950.00-foot radius non-tangent curve to the left; thence Northerly 73.87 ft. along the arc of said curve and said easterly right of way line and no-access line (Note: Chord to said curve bears N. 08°12'02" W. for a distance of 73.87 ft.) to said northwesterly right of way line; thence N. 57°50'00" E. 1044.51 ft. along said northwesterly right of way line to the point of beginning. 

Pursuant to Title 72, Chapter 6, Section 117, Utah Code Annotated, 1998, as amended, the above described tract of land is granted without access to or from the adjoining freeway over and across the westerly boundary line of said tract of land.


Together with and subject to any and all easements, rights of way and restrictions appearing of record or enforceable in law and equity.
