RIGHT OF WAY DEED

SHAFER, HARRY ALVIN SHAFER and HELEN RAE SHAFER, his wife, CLIFFORD LEROY SHAFER and DELLA MAE SHAFER, his wife, grantors, of Salt Lake County, Utah, for and in consideration of \$1.00 and other valuable consideration, do hereby grant, convey and warrant unto the GRANGER-HUNTER IMPROVEMENT DISTRICT, a political corporation, with its principal place of business in Salt Lake County, State of Utah, a right of way for the installation, repair, maintenance and replacement of a water pipeline, together with all valves, meters and appurtenant works at any point within Shafer Lane, a private road in Salt Lake County, State of Utah, which said lane runs south from 3500 South Street, and is more particularly described as follows to wit:

A 33 foot right of way 14 feet on the east and 19 feet on the west from a line described as follows:

Beginning at a point 33 feet South and 385.5 feet west from the Northeast corner of the Northwest quarter of said Section 34, Township 1 South, Range 1 West, SLM, thence running South 110 feet; thence on a curve to the left with a radius of 394.4 feet, 48.69 feet; thence on a curve to the right with a radius of 394.4 feet, 48.69 feet; thence South 400 feet. *J.P. Shafer*


