- 5. As a result of these events, Peter Todd Simpson does hereby give notice that he has accepted appointment to be the Trustee of the Trust and to fulfill his responsibilities and obligations as set forth in the trust agreement.
- 6. From this date forward, ownership of the above real property shall vest in the name of Peter Todd Simpson, Trustee of The Peter Henry Haig Simpson Trust dated October 27, 2021.


