

the following described tract of land in Weber County, State of Utah: Addition to Frontage Road R.O.W. to be deeded from Flying J Inc. to Weber County. A part of the NE 1/4 of Sec. 25, TWN 6 N, R2W, S.L.B.&M., U.S. Survey, Weber County, UT. Beginning at the inter-section point of the SE line of the Layton Intake Channel and the E line of an existing 40' wide Frontage Road, said point of beginning being E 842.45 feet + along the Section Line (as it existed prior to the setting of new monument in 1983) and S 162.14' + from the N. Quarter Corner of said Sec. 25 and running thence 3 courses along the E. line of said Frontage Road S. 10°02'06" E. 646.11'; SE along the arc of a nontangent 1055.92' radius curve to the left a distance of 492.37' (L.C. bears S 24°47'10" E 487.93'); S 38°08'40" E 409.24'; thence S 78°32' E 12.33'; thence N 38°08'40" W 168.62' feet on a line parallel to and 8' distant from said easterly line of Frontage Road; thence N 51°51'20" E 6.00'; thence N 38°08'40" W 250.00' on a line parallel to and 14' E. from the E. line of said Frontage Road; thence NW along the arc of a 1041.92' radius curve to the right a distance of 511.17' (L.C. bears N 24°05'23" W 506.06'); thence N 10°02'06" W 630.39' on a line parallel to and 14' E. from said E. line of said Frontage Road to an existing fence on the SE line of the Layton Intake Channel; thence along said fence S 43°56'30" W 16.92' to the Point of Beginning.




