## SPECIAL WARRANTY DEED

A parcel of land in fee for the widening of an existing roadway, State Route 97 (Roy 5600 South), known as Project 0097, being part of an entire tract of property situate in the SE ¼ SE ¼ of Section 16, To. 5 N., R. 2 W., SLB&M. The boundaries of said parcel of land are described as follows:
