FENCE LINE BOUNDARY AGREEMENT

WHEREAS, Utah State Department of Transportation owns a certain tract of real estate located in Utah County, Utah, and

WHEREAS, the boundary line between said tracts of land is an established fence which has heretofore been maintained and recognized by the parties and their predecessors in interest as the division boundary line between their respective properties, said parties each having been in possession of their respective tracts only up to the said fence line and

WHEREAS, the boundary line has been described as being located according to a survey by Joseph F. Varoz, registered land surveyor No. 3839, employed by the Utah State Department of Transportation, under date of December 6, 1977.

A tract of land situate in SW\(\frac{1}{2}\) of Section 9, T. 6 S., R. 2 E., S.L.B.&M. The boundaries of said tract of land are described as follows:

Beginning at a point on an existing property line fence, which point is 2076.59 ft. N. 0°41'06" W. along the ½ section line and 23.01 ft. S. 87°22'05" W. from the S½ corner of Section 9, Township 6 South, Range 2 East, S.L.B.&M.; said point has grid coordinates of X (East) = 1,937,597.272 feet and Y (North) = 720,129.471 feet, referred to the Utah Coordinate System, central zone; thence S. 87°22'05" W. 150.35 ft. along said fence line to a point on the easterly no-access line of a highway known as Interstate 15; thence N. 15°32'30" E. 334.87 ft. along said no-access line to the southerly property line of Mountain Fuel Supply Company; thence N. 89°16'05" E. 56.69 ft. along said property line to a point on the westerly right of way line of 1200 West Street; thence S. 0°41'06" E. 316.47 ft. along said right of way to the point of beginning.
