A regular meeting of the City Council of Farmington City, Davis County, Utah, was held on Wednesday, April 21, 1999, at the hour of 7:00 p.m. at its regular meeting place in Farmington, Utah, at which meeting there were present the following members who constituted a quorum:

After the meeting had been duly called to order and the minutes of the preceding meeting read and approved, the following proceedings, among others, were duly had and taken:

On April 7, 1999 the City Council considered protests which were filed against the creation of Special Improvement District No. 99-1 and determined to continue the protest hearing to April 21, 1999.

The City Manager then advised the City Council that because of protests received by the City, certain proposed improvements should be deleted from the District as set forth on Exhibit "B" attached hereto and made a part hereof, which deletions were approved by the City Council.

The City Manager then advised the City Council that the City has compiled the total written protests submitted to the City and has eliminated all written protests which were subsequently withdrawn or which protested those improvements which have been deleted from the District.

The names of the remaining protestants and descriptions of their property are as follows:

After consideration of such protests, the City Council determined to delete certain improvements as reflected in the Revised Notice of Intention included in Resolution No. 99-14. The City Council further determined that the total lineal feet and square feet represented by protests of the improvements described in the Revised Notice of Intention are less than fifty percent (50%) of the total lineal feet and square feet to be assessed within the District and is a percentage insufficient to legally protest creation of the District as modified.

Councilmember Larry Haugen introduced the following resolution in writing, which was fully discussed, and moved its adoption:

RESOLUTION NO. 99-14

A RESOLUTION TO CREATE FARMINGTON CITY, UTAH SPECIAL IMPROVEMENT DISTRICT NO. 99-1 DESCRIBED IN THE NOTICE OF INTENTION CONTAINED HEREIN CONCERNING THE DISTRICT AND AUTHORIZING THE CITY OFFICIALS TO PROCEED TO MAKE IMPROVEMENTS AS SET FORTH IN THE REVISED NOTICE OF INTENTION TO CREATE THE DISTRICT; AUTHORIZING THE CITY ENGINEER TO PREPARE A NOTICE TO CONTRACTORS FOR SEALED BIDS WITH RESPECT TO THE CONSTRUCTION OF THE IMPROVEMENTS; AND RELATED MATTERS.

BE IT RESOLVED by the Mayor and City Council of Farmington City, Davis County, Utah:

Section 1. The City Council of Farmington City, Davis County, Utah, hereby determines that it will be in the best interest of the Municipality to construct certain improvements within the Municipality. The specific description of the nature of the improvements is more particularly set out in the Notice of Intention which has been published and mailed as required by law with the deletions described hereinabove.

Section 2. The City Council has heretofore considered each and every protest filed and has heard each and every person who wished to be heard in protest against the creation of the District or making of any of the improvements therein or on any other matter pertinent to the District. In light of such protests, the City Council hereby revises pertinent parts of the Notice of Intention so as to read as follows:

REVISED NOTICE OF INTENTION

DESCRIPTION OF DISTRICT

The boundaries of the proposed District shall coincide with the city limits of Farmington City, Utah as of the date of this Notice of Intention.

INTENDED IMPROVEMENTS

The improvements to be constructed and their location within the District are as follows:

1. The construction of 30" high back curb and gutter, including excavation, road base, removal of existing concrete flatwork or asphalt pavement and back fill of top soil where required up to five feet behind the top back of curb:

- 100 West from State Street to 100 North (west side)
- 100 West from a point beginning 330 feet north from the north side of State Street, thence North 165 feet (east side)
- 100 North from 100 West easterly 201.5 feet (south side only)
- 200 East from 100 North to connect to existing curbs (both sides) at approximately 450 North (west side), and 475 North (east side)
- 200 East from State Street to 100 North (east side only)
- 100 East from 200 North to 500 North (both sides) (except properties fronting 258 and 278 East)
- 100 East from 100 North to 200 North (east side only)
- 100 East from 100 North northerly approximately 285 feet to existing curb (west side approximately 159 North)
- 200 North from 100 East to 200 East (both sides)
- 300 North from Main to 200 east (both sides) (except properties fronting 114 and 128 East)
- 400 North from Main to 100 East (both sides) (except 147.5 feet on north side beginning from east side of Main Street)
- 400 North from 100 East to 200 East (north side only)
- 400 North from 100 East easterly approximately 173 feet to existing curb (south side approximately 120 East)
- 100 North from 100 East to 200 East (north side only) except properties fronting 167 and 198 East but including properties fronting approximately 160 and 196 East on south side only
- 200 North from 200 East, easterly approximately 195 feet (both sides)

2. The excavation and construction of 30" high back curb and gutter, including excavation, road base, removal of existing flatwork or asphalt pavement and backfill of top soil where required up to five feet behind the top back of curb. City to pay 50% of cost.

- 200 North from Main Street to 100 East (north side only)
- 100 North properties fronting 167 and 198 East
- 300 North properties fronting 133, 151 and 155 East
- 400 North (north side)
- The east 20 feet of property address 410 North Main Street

3. The excavation and construction of curb and gutter and a 5 foot sidewalk, with the City paying 50% of the sidewalk cost. The cost of the curb and gutter includes excavation, road base, removal of existing flatwork or asphalt pavement and back fill of top soil where required up to five feet behind the top back of curb:

- 200 East from State Street to 100 North (west side only)
- 100 North (south side only) fronting properties at approximately 132 East, 138 East and 150 East

4. The construction and installation of concrete driveway approaches along the streets to be improved. The concrete driveway approaches shall extend 4 feet from back of curb with a minimum width of 10 feet. Driveway approaches wider than the minimum width shall be determined by each individual property owner. This requirement may be waived if flooding potential is non-existent as determined by the City Engineer.

OPTIONAL IMPROVEMENTS

The following optional improvements may be made available to property owners whose property is proposed to be assessed within the District and may be constructed at the discretion of each individual property owner with the costs added to their assessments. All such improvements to be financed must be constructed or provided by the duly selected contractor.

1. Addition of top soil or fill material beyond the 5 feet furnished behind the curb.
2. The removal and/or replacement of existing concrete driveways beyond the new 4 foot long drive approach. This can include complete removal of existing subgrade and replacement with base stabilization material.

3. The relocation of mail boxes.
4. Removal and replacement and/or installation of sidewalk.

ESTIMATED COST OF IMPROVEMENTS

The total cost of improvements in the District as estimated by the City Engineer is \$874,441. Of this total cost the City will pay for all storm drainage work, grinding of old asphalt and concrete, base material for streets, new asphalt paving, the removal and replacement of handicap ramps and 50% of sidewalk and curb and gutter in certain areas in a total amount of approximately \$603,595, leaving a remainder of \$270,846, which shall be paid by a special assessment to be levied against the property abutting upon the streets to be improved or upon property which may be affected or specifically benefitted by such improvements. The property owners' portion of the total estimated cost of the improvements may be financed during the construction period by the use of interim warrants, in which case the interest on said warrants will be assessed to the property owners. The estimated cost to be assessed against the properties within the District and the method of assessment shall be as follows:

4. Removal of existing concrete	\$ 1.50	Per Sq. ft. of removed material
5. Excavation and removal of excess material	\$ 30.00	Per Cubic yd. of material
6. Mail box relocation	\$150.00	Each

LEVY OF ASSESSMENTS

It is the intention of the City Council to levy assessments as provided by the laws of Utah on all parcels and lots of real property to be benefitted by the proposed improvements within the District. The purpose of the assessment and levy is to pay those costs of the improvements which the City will not assume and pay. The method of assessment shall be by linear foot, square foot, cubic yard or per item as set forth herein.

The assessments may be paid by property owners in not more than ten (10) annual installments with interest on the unpaid balance at a rate or rates fixed by the City, or the whole or any part of the assessment may be paid without interest within fifteen (15) days after the ordinance levying the assessment becomes effective. The assessments shall be levied according to the benefits to be derived by each property within the District. Other payment provisions and enforcement remedies shall be in accordance with Title 17A, Chapter 3, Part 3, Utah Code Annotated 1953, as amended.

* * * *

Section 3. The improvements proposed and described in the Revised Notice of Intention to create the District are hereby authorized, and the District is hereby created as described within the Revised Notice of Intention.

Section 4. The City Council reasonably expects to reimburse from proceeds of debt to be incurred by the City Council, capital expenditures advanced by the City for the installation and construction of the improvements herein described in a maximum principal amount of \$270,846. This expectation constitutes a declaration of official intent of the City Council pursuant to Treasury Regulation Section 1.103-18(f)(ii).

Section 5. As required by law, the City Recorder is hereby authorized and directed to file a copy of the Notice of Intention and resolution creating the District as finally approved, together with a list of properties proposed to be assessed described by tax identification number and legal description, in the Davis County Recorder's office within five days from the date hereof.

Section 6. In addition to the requirements of Section 5 hereof, immediately upon its adoption, this Resolution shall be placed in the records of the City where it will be continuously available for public inspection on a reasonable basis at the office of the City during regular business hours of the City, from and after the date hereof through and including the last date of issuance of the bonds or such other time as is determined by the City.

Section 7. The City Engineer is hereby authorized to prepare a notice to contractors for the receipt of bids for the construction of improvements. Said notice shall specify the time and place for the receipt of sealed bids and shall publish the notice one time in a newspaper having general circulation in the Municipality at least fifteen (15) days before the date specified for the receipt of sealed bids. The City Council shall in open session at the time specified in the notice, open, examine and publicly declare the bids and may reject any or all bids when deemed for the public good and, at such or a later meeting, shall reject all bids other than the lowest and best bid of a responsible bidder. If the price bid by the lowest and best responsible bidder exceeds the estimated costs as determined by the City Engineer, the City Council may nevertheless award a contract for the price so bid. The City Council may in any case refuse to award a contract and may obtain new bids after giving a new notice to contractors or may determine to abandon the district or not to make some of the improvements proposed to be made.

Councilmember Pat Achter seconded the motion to adopt the foregoing Resolution. The Resolution was thereupon put to a vote and unanimously adopted on the following recorded vote:


