SUPPLEMENTAL AGREEMENT NO. 1, made and entered into this 12th day of January, 1968, by and between State of Utah, hereinafter called the Lessor, and the United States of America, hereinafter called the Government.

W I T N E S S E T H:

WHEREAS, by Lease dated May 18, 1965, bearing Government Contract No. FA65WE-4066, by and between the parties hereto, the Government is authorized to occupy approximately 10 acres of land and a right-of-way for access road in Sections 22 and 27, T. 6 S., R. 1 W., S.L. Mer., Utah County, Utah, in connection with its operation of a VORTAC Facility, such land being more fully described in the aforesaid Lease; and

WHEREAS, the Lessor is agreeable to amending the said Lease as provided below at the same rental rate applying in the aforesaid Lease;

NOW, THEREFORE, effective January 12, 1968, the parties do hereby amend said Lease in the following respects and these only:

- 1. Article 2 is amended to provide that the Lessor hereby leases to the Government the following described premises:

A plot of land containing 10 acres, more or less, described as the ~~NE 1/4 NW 1/4~~ Section 27, T. 6 S., R. 1 W., SLM, Utah County, Utah. Together with a right-of-way for access thereto across lands owned by the Lessor lying within Sections 27, 22 and 11 of said Township and Range. The right-of-way crossing Lessor's land is shown in red on the attached map designated as DR-WE-D-112-41531-2.

ALL OTHER TERMS AND CONDITIONS of the Lease are hereby ratified and except as amended hereinabove shall be and remain the same.
