Lots 1 through 34, inclusive, Parkview Meadows Subdivision Phase 1, situated in the City of Kaysville, in the County of Davis, in the State of Utah, do hereby, amend Section 2.1a. of the Declaration of Covenants, Conditions, Agreements and Restrictions recorded on <u>12/14/99</u> as Entry No.<u>1564057</u>, in Book<u>2593</u>, Page 1578, in the office of the Davis County Recorder, as affecting the real property described above.

- DWELLING-SIZE, QUALITY, EXTERIOR MATERIALS: The following minimum finished square foot living area 2.1 requirements shall apply. Living areas shall be calculated exclusive of garages, open porches, and basements. The ground floor shall be defined as the first floor with a floor elevation extending above the top back of curb at the driveway approach side of the lot.
  - a. Dwelling Size: The following dwelling sizes shall apply:

One Story Dwellings (Rambler): The required minimum ground floor finished space shall be 1400 square feet of ground floor finished space or more with a minimum 2-car garage required.

Two Story Dwellings: The required minimum above ground floor finished space shall be 1,700 square feet or more with a minimum 2-car garage.

Multi-Level Dwellings: The combined area of the ground floor and the adjoining levels, qualifying as stories as herein defined, shall be minimum of 1500 square feet or more with a minimum of 2-car garage required. THE ARCHITECTURAL CONTROL COMMITTEE RESERVES THE RIGHT TO GRANT EXCEPTIONS TO THE ABOVE RESTRICTIONS IN ORDER TO PLACE AN APPROPRIATE HOME ON A SPECIFIC LOT.
