AN ORDINANCE

AN ORDINANCE VACATING a portion of the alley east of 3rd West Street between Paxton and Lucy Avenues, all abutting property owners having petitioned for the vacation.

Be it ordained by the Board of Commissioners of Salt Lake City, Utah:

SECTION 1. That a portion of the alley east of 3rd West Street between Paxton and Lucy Avenues, more particularly described as follows:

Beginning at the northwest corner of Lot 31, Block 4, Davis Sharp and Springer's Subdivision of Lots 1, 19, 20 and part of Lots 2, 3, 4 of Block 24, Five Acre Plat "A", Big Field Survey; thence south 134.0 feet; thence west 12.0 feet; thence north 134.0 feet to the northeast corner of Lot 20 of aforesaid Block 4; thence east 12.0 feet to the point of beginning;

be and the same is hereby vacated and declared no longer to be public property for use as a street, avenue, alley or pedestrian way.

Said vacation is made expressly subject to all existing rights of way and easements of all public utilities of any and every description now located in, on, under or over the confines of the above described property; and also subject to the rights of entry thereon for the purpose of inspecting, maintaining, repairing, replacing, removing, altering or rerouting said utilities and all of them.

SECTION 2. In the opinion of the Board of Commissioners, it is necessary to the peace, health and safety of the inhabitants of Salt Lake City that this ordinance shall become effective immediately.

SECTION 3. This ordinance shall take effect upon its first publication.
