## QUIT CLAIM DEED

Subject to a right of way over a spur line commencing at a point 306 feet from the West side of Main Street and entering at that point on the above described property. The same extends 12 feet in width, the West side being .318 feet from the West side of Main Street, the spur line crossing said property from a northerly direction on Lot 7; the said 12 foot strip to be continuous to the north side of the above property and connecting with the D. & R. G. Right of Way as it enters said property.
