Jacob. Hunter and Mary A Hunter, his wife of Salt Lake County, Utah, grantors for the sum of One (1) Dollars, paid to grantors by The Telluride Power Company, a Colorado corporation, hereby grant to said company, its successors and assigns, the right to erect and maintain one (2) line of poles and electric transmission circuits across the following described tracts of land in Salt Lake County, Utah, to-wit:

The East one half (1/2) of the North west one quarter (1/4) and the South west one quarter (1/4) of the North East one quarter (1/4) of Section Numbered thirty-three (33) in township Numbered one (1) South of Range Numbered one (1) West of the Salt Lake Meridian.

The grantee herein to maintain the said lines where the same are now constructed over through and across the above described tracts. If in the future it shall become necessary to replace a pole or make other actual repair in said lines and in so doing the grantee and its employees enter upon said tracts and negligently trample do and destroy growing crops and fences on said tracts, then the owners of said lines shall pay unto the owners of said tracts the actual value of such destroyed crops and shall replace all portions of fences thus destroyed in as good condition as before said entry. And if trees on said tracts interfere with the said lines, the same shall be trimmed by the grantee under the direction of the grantor, and shall be kept a safe and proper distance from all wires.
