Clerk-Auditor) at the time of adoption of this ordinance for use and examination by the public.

### SECTION III:

1. The 1976 Revised Zoning Ordinance of Utah County, Utah and the County Zone Map of Utah County, Utah, 1976, and any previously enacted version or purported version of the Utah County Zoning Ordinance or Official Utah County Zone Map, or other zoning ordinance or zone map for the unincorporated area of Utah County, save the Utah County Zoning Ordinance and Official Utah County Zone Map adopted by this ordinance, are hereby revoked in their entirety.
