to \$146,000.00. The increase in the credit limit shall become effective on the 17

Note, or Guaranty and any other document used for the original loan shall remain unchanged and in full force
and effect.



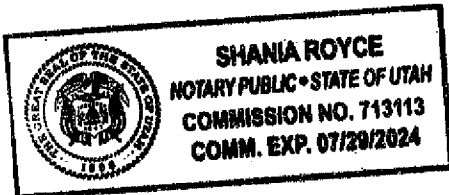
