AGREEMENT AMENDING PARAGRAPH 6 OF THE PROTECTIVE COVENANTS ON  
OLYMPUS VIEW SUBDIVISION

TO WHOM IT MAY CONCERN:

The undersigned, being the owners of all lots in Olympus View Subdivision, hereby amend Paragraph 6 of said Protective Covenants executed by Hyland Realty, Inc. and recorded March 18, 1958 in Book 1490, page 275, Official Records of Salt Lake County, State of Utah, and Amended Protective Covenants, recorded April 18, 1958 in Book 1498, page 29, Official Records, of Salt Lake County, State of Utah, to read as follows:

6. No residence shall be located on any residential building lot described above nearer than 30 feet to the front lot line, or nearer than 8 feet to any side lot line, excluding porches, garages, cornices, spoutings, chimneys and purely ornamental projections, and on side streets (corner lots) side yard to have 20 foot setback. If a carport or garage is constructed on the said building lot, detached or attached, it shall comply with the applicable zoning ordinances of Salt Lake County.


