A perpetual easement, upon part of an entire tract of property, situate in Lot 1, Plat "B", Lake Pointe Shopping Center Subdivision, according to the official plat thereof recorded June 22, 2010 as Entry No. 51439, Map No. 13268-145, situate in the NW1/4NE1/4 of Section 27, T.6S., R.2E., S.L.B.&M., for the purpose of constructing and maintaining thereon, public utilities and appurtenant parts thereof, incident to the Provo-Orem Transportation Improvement Project, known as project number S-0265(23)3. The Easement shall run with the real property and shall be binding upon the Grantor and the Grantor's successors, heirs and assigns.

Beginning at a point on the northerly project right of way line of State Route 265 (University Parkway) in Orem, Utah, which point is 74.75 feet S. 89°08'17" E. along the section line and 25.35 feet South and 537.90 feet S. 19°22'15" E. from the North Quarter Corner of said Section 27, which point is also 91.50 feet perpendicularly

The above described part of an entire tract of land contains 291 square feet or 0.007 acre in area, more or less.

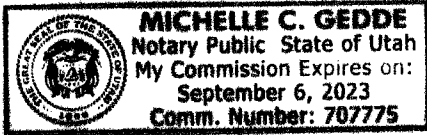
