CERTIFICATE RESPECTING RIGHT OF WAY

WHEREAS under date of July 16, 1949, Melvin E. Child and LuJuana Child executed and delivered to Salt Lake Pipe Line Company a grant of right of way, which was recorded July 23, 1949 in Book 5, page 24 of Official Records of Davis County, State of Utah, and

WHEREAS under date of June 17, 1952 Thomas Scott and Reah C. Scott executed and delivered to Salt Lake Pipe Line Company a grant of right of way, which was recorded July 8, 1952 in Book 39, page 455 of Official Records of Davis County, State of Utah, and

WHEREAS said grants of right of way covered a part of the Northeast Quarter of Section 26, Township 5 North, Range 2 West, Salt Lake Meridian, more particularly described in said grants, and

WHEREAS request has been made to Salt Lake Pipe Line Company to identify the location of its right of way within said parcel and to relinquish any claim of right of way to promises not affected by said right of way as located and established on the ground.

NOW THEREFORE for such purpose said Salt Lake Pipe Line Company, a corporation, does hereby certify that the right of way, held and enjoyed by it under said grant, as now located and established upon the ground, is confined to a strip of land lying within the westerly 50 feet of said parcel described in said grants. In addition, Salt Lake Pipe Line Company reserves the right to use any other dedicated streets for ingress to and egress from its pipelines and right of way. Said Salt Lake Pipe Line Company hereby releases and relinquishes any right or interest in or to the remainder of said parcel. In the event it becomes necessary to break or otherwise damage the surface or grade of any future street or road in order for Salt Lake Pipe Line Company to reconstruct, replace, renew, repair, change the size of, or increase the number of its pipelines, Salt Lake Pipe Line Company will restore the street to the approximate grade prior to such work with such material as is removed from the trench, but assumes no responsibility for providing additional fill and material or for repaving the portion of said street broken or damaged by construction work.
