RIGHT OF WAY DEED

F.A.P. 154-D-2, 53

William Evans and Lilly Evans, his wife grantor of Logan, County of Cache State of Utah, hereby grant, bargain and sell to the STATE ROAD COMMISSION OF UTAH, Grantee, for the sum of Eight 50/00 DOLLARS, the following described right of way across the grantors land in Cache County, State of Utah, as follows:

Right of way for highway known as F. A. Project No. 154-D across the grantors' land in NW 1/4 SW 1/4 of Section 33, T. 12 N., R. 1 E., S. L. M. Said right of way is contained within a strip of land 50 ft. wide, on the north side of the center line of survey of said project. Said center line is described as follows:

Beginning at the intersection of the east boundary line produced of said grantors' land and said center line of survey at Engineer's Station 41+75, which point is 307 ft. south along the west line of said Section 33 and 769 ft. S. 88° 42' E. along said center line of survey, from the west 1/4 corner of said Section 33; thence N. 88° 42' W., 725 ft. to the intersection of said center line of survey at Engineer's Station 49+00 and the west boundary line produced of said grantors' land, which point is 307 ft. south along said west line of Section 33 and 44 ft. S. 88° 42' E. along said center line of survey, from said west 1/4 corner of Section 33, as shown on the official map of said project on file in the office of the State Road Commission of Utah. Above described tract of land contains 0.83 acre, of which 0.77 acre is now occupied by the existing highway. Balance 0.06 acre.

In executing this deed, the grantors hereby grant to the State Road Commission of Utah permission to relocate and reconstruct within the grantors' land and outside the limits of above described right of way, all irrigation and drainage ditches existing within said limits of above described right of way.

The purpose of this deed is to grant a perpetual right of way for highway purposes.

Mark H. Painter and Irene P. Painter, his wife grantors of Logan, County of Cache State of Utah, hereby grants, bargains and sells to the STATE ROAD COMMISSION OF UTAH, Grantee, for the sum of Twenty Seven and 50/100 DOLLARS, the following described right of way across the grantors land in Cache County, State of Utah, as follows:

Right of way for highway known as F. A. Project No. 154-D across the grantors land in the N 1/4 SW 1/4 of Section 32, T. 12 N. R. 1 E., S. L. M. Said right of way is contained within a strip of land 50 ft. wide, on the south side of the center line of survey of said project. Said center line is described as follows:

Beginning at the intersection of the east boundary line produced of said grantors land and said center line of survey at Engineer's Station 87+82, which point is 307 ft. south along the east line of said Section 32 and 3838 ft. N. 88° 42' W. along said center line of survey, from the east 1/4 corner of said Section 32; thence N. 88° 42' W., 672 ft. to the intersection of said center line of survey at Engineer's Station 94+54 and the west boundary line produced of said grantors land which point is 307 ft. south along said east line of Section 32 and 4510 ft. N. 88° 42' W. along said center line of survey, from said east 1/4 corner of Section 32, as shown on the official map of said project on file in the office of the State Road Commission of Utah. Above described tract of land contains 0.77 acre, of which 0.67 acre is now occupied by the existing highway. Balance 0.10 acre.
