together with rights of ingress and agress to and from said line or lines, or any of them, for the purposes aforesaid. For the same consideration, Grantee shall have the right to use, for purposes of constructing and installing the initial line or lines, an additional strip of ground 2 rods in width contiguous and parallel to the route of such initial line or lines.

The Grantor reserves the right to use and fully enjoy the above described premises, except as to the rights hereinbefore granted.

All pipe laid under this grant shall be laid upon routes selected by the Grantez, and shall, when requested by Grantor, be buried to such depth as not to interfere with the ordinary cultivation of said land.

To have and to hold said easements, rights and rights of way, unto the said Grantee, its successors and assigns, forever.

Should additional pipelines be laid at any time under this grant, after the construction of the initial line or lines, an additional consideration of \$3.50 per lineal rod shall be paid for each pipeline so laid after the initial line or lines; provided, however, that multiple pipes laid in a single excavation shall constitute a single pipeline for the purposes hereof.

Upon completion of construction of each pipeline laid hereunder, Grantee shall restore the surface of lands utilized in the installation thereof to substantially its original condition, including removal of rocks from the surface of irrigated or cultivated portions thereof, and shall restore and repair all fences damaged by operations hereunder.
